- The Seller warrants that they are fully entitled to sell them.
- Funds are available at the next tender sale following payment from the buyer.
- Tender Disposals has the right to exclude goods from sale.
- Sellers removing goods from sale before the statutory 3 weeks will be subject to a \$25 handling fee.
- All items are stored at the owner's/sellers risk. Insurance is the responsibility of the owner/seller.
- Should a dispute occur with a Tenderer / Buyer, recourse must be directed only at the tenderer / buyer.
- Goods with a reserve price will be entered into a maximum of 3 sales, if not sold must be collected by the date shown.
- Goods uncollected after 3 sales are subject to 10% reduction of reserve price each sale until sold or collected.
- Goods uncollected within 7 days of a collection notice or 6 months from lodgment date will be deemed abandoned, become Tender Disposals property and may be disposed of or incur a daily storage fee, at the discretion of Tender Disposals.
- Goods requiring in the opinion of Tender Disposals Staff cleaning or assembly will be subject to a \$15 Fee.
- Goods valued at \$20 or less will be offered at 'NO RESERVE' and sold on the spot or to the highest bid.
- Anyone entering Tender Disposals premises does so at their own risk.
- The Seller agrees to pay the commissions and charges shown. The Seller also agrees and authorizes Tender Disposals to deduct any commission and credit card charges from the balance payable.
